**Release, Waiver of Liability and Indemnification Agreement**

This release, Waiver of Liability and Indemnification Agreement (“Release”) must be signed by each participant and witnessed prior to riding in any race. Any participant who has not signed this Release prior to any race is disqualified from participating or winning.

Whereas, the Delaware Valley Point-to-Point Association (“Delaware Valley”) is conducting events, including point-to-point races (“Horse races”) on the following dates and locations:

1. Mr. Stewart’s Cheshire Foxhounds Point-to-Point Races, Unionville, PA – Sunday, March 30, 2025
2. Brandywine Hills Point-to-Point Races, Northbrook, PA – Saturday, April 6, 2025
3. Mount Harmon Wicomico Point-to-Point, Earleville, MD – Sunday, April 13, 2025

WHEREAS, the undersigned wishes to participate in any one or all of the events and the horse races; and

WHEREAS, the undersigned is aware that point-to-point races are athletic events which pose serious personal risks, including injuries, death or property and other damages to the participants, horses or other property of the undersigned (hereafter “Injuries”) as a result of the undersigned’s negligence, the negligence of others or through no fault of the undersigned or anyone else because of the nature of the activity which the undersigned is going to be engaged in, and the undersigned also understands that horses, even the most well trained, are often unpredictable and often difficult to control,

With the knowledge of the foregoing and as an inducement for Delaware Valley and the landowners to participate in the event and the races, the undersigned hereby signs this Release in favor of the Delaware Valley Point-to-Point Association, the landowners, other participants and all other persons and entities (“those released”) for all injuries on his own behalf and on behalf of any and all persons who could claim through or on behalf of the undersigned including, but not limited to, his heirs, executors and administrators, personal representatives, guardians, spouses and issue.

The undersigned agrees to waive and release (give up) any and all rights that the undersigned has to make a claim against those released arising from injuries which the undersigned may sustain or which may occur as a result of or in connection with the event or the horse races or otherwise.

The undersigned further agrees to indemnify (hold harmless) those released from any claims for injuries which the undersigned might make or which might be made on the undersigned’s behalf by others arising from the event or the horse races.

The undersigned indemnifies (holds harmless) those released for injuries in connection with the event or the horse races. It is the undersigned’s intent and agreement to hold harmless those released.

The undersigned agrees that in signing this release, waiver and indemnification agreement, the undersigned understands that the undersigned is giving up (waiving or releasing) any right that the undersigned has to sue or make claims arising or occurring from the injuries against those released which the undersigned might incur or sustain in connection with or while participating in the event, including the horse races.

The undersigned has had the full opportunity to read and understand this legal document and has done so. The undersigned signs this document knowingly and voluntarily.

The undersigned authorizes and agrees to emergency medical care which may be necessary in the event of injury to the above minor or to any horse that he may be riding.

The undersigned participant is deemed to be acting as the authorized agent for the owner and the trainer.
